

REQUIREMENTS FOR ACCESSING THE CASE INFORMATION SECTION

The subscriber must first acknowledge that he/she is a duly licensed Attorney by submitting his State I.D. number. Said name and I.D. will be verified and if it is not confirmed, the subscriber's access will be denied.

Subscribers will also have to accept the following agreement. A "do not agree" entry would preclude their accessing the case information area.

AGREEMENT

Prior to accessing the "Attorney's case information questionnaire" the subscriber does hereby agree to the following terms:

That the subscriber is an Attorney At Law, duly licensed to practice in the State and jurisdiction where he resides and conducts his practice. Should the referenced information be misrepresented, access to the "case information" section will be denied.

The subscriber accepts that any response rendered is based solely on the information provided by the subscriber and should not be considered an opinion or judgment of the case; nor should that response be used to influence the manner by which the case is prepared for trial, arbitration, mediation or settlement.

The information contained in the "Security Checklist", is designed to aid the attorney in further preparing his case and providing an expert witness with additional discovery documentation for presentation of his opinion during oral testimony either at deposition or trial.

The information may also be used to educate the attorney as to those security issues which may be addressed by an expert employed by opposition council.

It is to be understood David L. Berger, or any Experts referred by him, are not, so-called, "hired guns". They will not submit to having their testimony managed or manipulated. It is our honest opinion that an expert witness, in any discipline, is honor bound to deliver an accurate, honest evaluation of their review of all of the discovery material and other documentation and evidence available to the client attorney so that the attorney may better represent his client. It is also necessary to advise that attorney of issues he will ultimately face at trial that may not be favorable to his client's interests. He will, after all, be facing another expert at trial who has been furnished with similar documentation and evidence.

The subscriber agrees to indemnify and hold harmless David L. Berger, along with the "Security Checklist" from any and all claims relevant to their participation in the case at issue, regardless of whether it is involving the rendering of an initial opinion by virtue of the submission of this questionnaire or by providing written or oral testimony at deposition, arbitration, mediation, trial or any other hearing.
